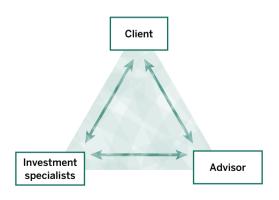

Growth profile

Objective: to substantially appreciate the value of the portfolio in the long term.

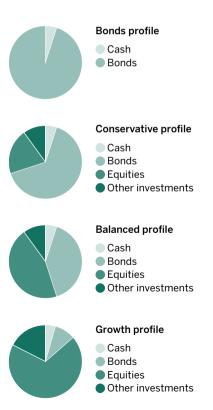
Return: mainly comprising capital gains and current interest and dividend income to a lesser extent.
